Minutes for the September 1, 2020 meeting were reviewed. Motion to accept was made by Sue, seconded by Angie, and carried. Minutes of the September 27, 2020 meeting were reviewed and approved with the motion made by Scott and seconded by Julie.

Bills were reviewed. Building Maintenance reflects \$1329.73 for display panels was paid for with the Visa credit card with reimbursement to come from the donations account. Motion to accept the report and payment of bills was made by Sue, seconded by Angie, and carried.

- c. Albany School Update
 - Flyers distributed to students; library card applications are trickling in
 - Melissa updated on school district status related to Covid-19
- d. Silent Auction
 - Donations are down and more are needed
 - Jolene will begin staging and photographing items
 - Prepared for a lower-than-average fundraising event
- e. Display Panels
 - Doug Horn was hired to begin installation
- f. Solar Panels
 - i. Grant Status answer expected by October 15th
 - ii. Roof Replacement
 - Additional bids needed
 - Wayne prefers replacing roof now rather than after solar panels are installed
- g. Emergency Plan sick leave
 - Carolyn noted that the current sick leave policy is a general policy not related to the emergency plan
 - Sue will look into changes necessary to ensure that the library director receives sick pay
 - Sue made a motion to accept the proposed changes; seconded by Eileen; carried

New Business

 15th
 - Motion to approve budget as proposed by Eileen; seconded by Sue; carried
